Instructions for filling out the application and calculating the total due.

Use the codes listed on your current license. If you had a business license with us last year, use that license. The title on the license was Russell County, Alabama across the top and showed a green background.

**Column B and Column C**

List the section Numbers and brief description of each code in the space provided from your current license. At the end of your description please list the code table that is used. Example: The first part on the license would be the 4-6 digit code - the description - then a letter, that last letter would be the schedule used.) Please list that code at the end of your description and circle it.

**Column A**

In this column, please list your gross receipts associated with each section rounded up to the whole thousands. You have the option of using receipt from all of 2010 or October 1st 2010 through September 30th 2011 depending on how you have been reporting. If your business is located within Russell County, regardless of where you conduct business, you are to report your total gross receipts for your business. If your are located outside the jurisdiction of Russell County, you are only to report Russell County gross receipts.

**Column D**

Once you have your codes, your gross receipts for each section (if required), and your fee schedules, you are ready to begin calculating the total due.

Suppose that last year you were a Electrical Contractor, your code was 238210 and your fee Schedule is E. If you have gross receipts last year of \$325,450 **rounded up** to the whole thousand of \$326,000. Now they would use this figure to calculate the total due.

Look up your base fee first.

\$326,000 falls between the \$300,000 to \$400,000 range  
That gives a base fee of \$315.00.

Now for part 2.

The schedule states \$0.83 per thousand in excess of \$300,000  
Take your total figure and subtract \$300,000 from \$326,000  
The remainder is \$26,000 which you divide by 1,000 equaling 26.  
Multiply 26 by \$0.83, which equals \$21.58  
Add your base back in, \$315.00 plus \$21.58 equals \$336.58  
\$336.58 is your license fee that you would put in column D of the application.

**Column F**

Add Column D to Column E to render Column F.

Subtotal the items in column F and put total on line 3 column F

**REPEAT FOR ALL SECTIONS NEEDED!**

**Late Payments and Citation Fees**

If your payment is late (Received after October 30th) you must include penalties and interest on the amount due. The interest rate is 0.75% per month late. Multiply 0.75% by how may months you are late (even a fraction of the month constitutes a month to get your interest rate. For your penalty, if you are paying in November the penalty is 11.25% otherwise 22.5% thereafter. If you received a citation please add an additional \$75.00 citation fee and notate that you received a citation or include it with your renewal.

Add your penalty and interest totals together and multiply that figure by your total of column D. Add in the citation if applicable and put this amount on line 4 column F

**Total Amount Due**

Add Line 3 and Line 4 to yield line 5. This is the total that you owe.
